Rules of the Agreement

1. Customer acknowledges receipt of the equipment identified on the front of this form, which was examined by the Customer and found to be in first-class condition except as noted in the Current Damages section of this form. Customer further acknowledges that the equipment is rented by the Lessor to the Customer for the use and purpose for which it was manufactured, subject to the terms and conditions set forth herein.
2. Customer shall return the equipment or allow for pick-up of the equipment no later than the Date of return specified within this agreement. Customer shall contact the Lessor if Lessor requests, if an extension of time is desired by the Customer, or if any accidents/damage occur.
3. Payment shall be made in full at the time of rental, unless otherwise agreed to by Lessor.
4. Customer shall reimburse Lessor, upon demand, for the loss of or any damage to the cart or property while the equipment is rented by the Customer. This shall include, but is not limited to, all costs and expenses to repair or replace the cart, accessories, charger, and/or damages caused to property made by the cart, and reasonable attorney fees incurred by the Lessor in collecting any amounts owed by the Customer. Upon return of the cart, the Customer is responsible for any damages **not** listed in the Current Damages section of this agreement.
5. Customer shall identify and hold Lessor harmless from and against any and all liability, including bodily injury and property damage arising out of the use or operation of the equipment by the Customer or anyone using or operating the same with the Customer's express or implied consent.
6. Customer shall abide by all rules and regulations of the Lessor and this agreement governing the use of the equipment. See Golf Cart Rules below.
7. Customer shall not assign the Rental Contract or sublease the equipment.

Golf Cart Rules

1. Customer must be a minimum of 21 years of age.
2. Operator of cart must have a current and valid driver's license.
3. Carts operated after sunset must have lights and lights must be turned on.
4. Carts must be operated properly. Horseplay, racing, and other misuse of cart will not be tolerated.
5. Reckless driving is prohibited at all times.
6. Alcohol is not permitted on the rented cart. It is against the law to operate a moving vehicle while under the influence of drugs and/or alcohol. If the customer or operator of the cart is found to operate the cart under the influence of drugs and/or alcohol, the Customer will immediately lose rental privileges and all monies for the rental of the cart.
7. All cart drivers and passengers must be seated at all times when the cart is in motion.
8. Cart must remain at the rental location at all times and not to go beyond posted areas.
9. Anyone found abusing or violating any of the rules in this agreement, or state and/or federal laws will forfeit all rental privileges. There will be no refunds made if the cart has to be returned because of Customer misuse.
