• I authorize Paws and Claws Pet Resort to allow my pet(s) to engage in social play with other pets. In doing so, I understand my pet(s) may become injured by interacting with other pets. I also understand that Paws and Claws Pet Resort has evaluated the personalities of all pets engaged in play, and will use reasonable care to ensure that no injuries result. However, in the event that an injury does occur to my pet(s) during group play, I agree to hold Paws and Claws Pet Resort harmless from damages resulting from such injury. *I agree to pay all veterinary charges required to properly treat my pet(s) for such injury.* **Initial:** _____

• I understand that due to the excessive running and playing outdoors, my pet's paws/pads may be sensitive & tender as a result from worn pads. If your pet is an indoor pet, please communicate this so we can watch for sensitive pads. **Initial:** _____

• All pets are boarded, trained or otherwise cared for by Paws and Claws Pet Resort, without liability on its part for loss or damage by or from disease, death, running away, theft, fire, or injury to persons, other pets, or property by or to said pet(s), or other unavoidable causes, due diligence and care having been exercised. **Initial:** _____

• I understand that all pets at Paws and Claws Pet Resort are vaccinated and healthy, but that there are viruses (e.g., colds, Bordetella, Conjunctivitis, Giardia, and Papilloma Virus) that cannot be fully vaccinated against and that in a social setting such as day care, my pet may be exposed to such. **Initial:** _____

• Daycare/boarding charges are still applicable even if the pet(s) are not participating in playgroup daycare to include: pets that have been pulled for diarrhea, vomiting, sore pads, "behavior time outs" or any other reason, for the session or for 24 hours. **Initial:** _____

• If your pet requires medical attention while in the care of Paws and Claws Pet Resort, ***you agree to be solely responsible for the payment of all medical bills*** for your pet and you release Paws and Claws Pet Resort, its officers, and employees from any and all responsibility for, or claims, damages, debts, resulting from such medical care, including but not limited to, transportation to/from the veterinarian clinic and choice of veterinarian or animal hospital. **Initial:** _____

• To qualify for playgroup daycare, eligible pets are required to be spayed or neutered and temperament tested. (Pups younger than 8-months-old needn't be spayed or neutered.)

ADDITIONAL HEALTH POLICIES

• Any pets showing signs of extreme lethargy or signs of heat stress will be taken to the veterinarian immediately even if we are unable to contact you first. **Initial:** _____

• Pets that are heartworm positive or undergoing heartworm treatment are not permitted for any services. Once the treatment for heartworms is complete, veterinary recommendation is to wait 6 months before testing for heartworms to avoid a false positive.

• Pregnant females are not permitted for any services.

• Paws and Claws Pet Resort is a tick and flea-free environment. If a pet has fleas/ticks, the pet will be bathed and treated at the owner's expense(not to exceed \$50). **Initial:** _____

Paws and Claws Pet Resort Daycare and Boarding Agreement

- Pups with open wounds, fresh hot spots, or stitches are not eligible for playgroup daycare or grooming services.
- I understand that boarding, daycare, and grooming may cause stress to my pet(s). This could lead to stress induced diarrhea/vomiting, commonly known as "stress colitis". I do not hold Paws and Claws Pet Resort liable for this occurrence. **Initial:**_____
- I understand during boarding, my pet may be exposed to insects such as spiders, ants, bee's, or wasp's. I give Paws and Claws Pet Resort consent to take my pet to a veterinarian to treat my pet at the owner's expense if my pet ingest or gets stung by said insect. **Initial:**_____

VACCINATION REQUIREMENTS:

- We require documentation of Rabies and Distemper /Parvovirus every year or 3 years (depending on the vaccines your veterinarian administers), Bordetella annually and we highly recommend the bivalent canine influenza vaccine (H3N2&H3N8) annually. Any expired vaccination must be administered 5 days in advance of boarding/daycare or grooming. Paws and Claws requires all vaccinations to be administered by a licensed veterinarian listed on a printed invoice.
- Puppies must be at least 16 weeks old and finished with their puppy boosters before they can come in for any services. We require 3 distemper/parvo boosters, a current rabies vaccine and an annual Bordetella vaccine. Once they receive their last booster there is a 5-day waiting period that starts the day after the last booster is given before they can be boarded or join daycare. **Initial:**_____
- Cats require current rabies and feline distemper (FVRCP). Feline Leukemia is recommended.
- I certify that my pet(s) is/are current on all vaccinations and is/are to my knowledge in good health. and to my knowledge;said pet(s) has not been exposed to Distemper, Rabies, or Parvovirus within the last 30 days. **Initial:**_____

ADDITIONAL BOARDING POLICIES:

- There is a \$3.00 per day charge when feeding your pet with "house" food. **Initial:**_____
- We cannot guarantee that toys and beds will be kept in the same condition as brought in. For safety reasons, tennis balls and rawhide are NOT permitted. **Initial:**_____
- All pets need to be able to be handled and cared for by our staff. In the event your pet is not able to be handled, or is showing signs of aggression, he/she will need to be picked up immediately. **Initial:**_____
- Please bring medications in a container (preferably in the original bottle). There is no charge for administering medication.

BORDETELLA Agreement

Paws and Claws Pet Resort follows the American Boarding Kennels Association recommendation requiring the Bordetella (Kennel Cough) vaccination annually. However, vaccinated canines are still susceptible to various strains of the virus. The vaccines for Bordetella only cover a few strains of the virus. I understand that although my pet is vaccinated against Bordetella, it is not a guarantee that my pet will not contract some form of the virus. I also understand that although rare, Kennel Cough can evolve into more serious respiratory infections that may become critical, i.e. bronchopneumonia or chronic bronchitis. It is a heightened risk for puppies, senior pets, or immunocompromised pets. I understand these risks and will not hold Paws and Claws Pet Resort liable or responsible for any veterinary expenses.
