President Travis Schroll called the meeting to order and roll was taken. Commissioners present included: Travis Schroll, Stacy Sloan, Becky Jones and Mandy Hardwick. Deion Summers and Josh Reich were also present.

The 04-13-22 meeting minutes were approved on a motion by Becky Jones and a second from Mandy Hardwick.

Deion Summers made the following Director's Report:

- The Park District "rolled over" last year's TIF funds in the amount of \$40,000.00. The Park District will receive another \$40,000.00 in TIF funds for this fiscal year, leaving us with a total amount of \$80,000.00 to spend on approved projects.
- The condition of the gym floor was discussed, and Deion agreed to obtain a price on replacing the floor.
- 12 people applied for the Administrative Assistant position, but no candidate for the position was identified.
- Construction will begin on 05-12-22 on the shelter over the pool concession area and it should be complete within (3) days.
- The Open Meetings Act Training needs to be completed by all Park District Board Commissioners.
- Work on the JBS soccer complex continues and work permits are being obtained. Competition fields should be ready in August of 2022. The building which will contain a storage area, concession stand and bathrooms, should be constructed in the Fall of 2022.
- The swimming pool opens on May 28, 2022.
- A tentative 2022/2023 Park District budget was discussed. The budget and notice will be posted in the newspaper and the budget will be voted on at the June 2022 Park Board meeting by the Board of Commissioners.

Park Board officers will remain in their current positions until the June 2022 Park Board meeting.

Becky Jones made a motion and Mandy Hardwick seconded for the Park District Board of Commissioners to go into executive session to discuss staff compensation.

  with a possible donation from JBS. Graham and Hyde were given a project budget of 3 million dollars,
  but the completed renderings come with a project cost of 11 million dollars. Deion will contact
  Graham and Hyde to discuss renderings that fit within the budget provided to the company of 3 million
  dollars. Travis Schroll stated he could talk with them as well.
- Deion has contacted Myers and Myers to request the required audit of the Friends of Beardstown bank account and to complete the 990EZ form which is required for the Park District's tax-exempt status.

A budget of \$1,500.00 will be allowed for the purchase of trees on a motion by Stacy Sloan and a second by Mandy Hardwick. - The brick planters at the old circle drive by the swimming pool will be removed and replaced with grass in the Spring. Trees will be planted at the location in the Fall of 2022. There will be a Memorial Tree program developed to plant trees around the parks.
- There was discussion regarding re-routing the walking path away from the back section of Roy Roberts Park in 2022. Sections of the walking path are currently in poor condition and will need to be replaced/repaired.
- Basic tools and maintenance equipment are needed (drill, impact saw, grinder, shop vac and mower lift). The approximate cost is \$1,000.00. New field drags will need to be purchased for the 2022 baseball/softball season.

- Employee Christmas gift cards were tabled until a further meeting with Myers & Myers.
- The membership fees and daily passes will increase as of January 1<sup>st</sup>, 2023.
- Purchase of a new treadmill has been tabled until a further meeting with Myers & Myers.
- Soccer bid packets are done and advertised. Myers and Myers have the Friends of Beardstown audit paperwork.
- The trees from Boehm's were planted around the park.
- Seth Coats has a water tank that can be used by the park district starting in January.
